1. This agreement is valid from 1-1-2019 until 31-12-2019, and will be evaluated for renewal in September 2019 with underneath mentioned targets.

The intention of both parties is to have a contract for 2019 and 2020. For the renewal of the contract in 2020, clear goals are set to achieve in 2019.

The targets in 2019 are:

- Sales of tyres in 2019 – minimum 40.000 units
- Inter-Sprint group brands SoA minimum 60%
- Introduction Roadhog with summer and winter offer
- Minimum of 10 new members Fagdekk joining the program with Inter-Sprint.
With a minimum turnover of 400 units per member in 2019

How to achieve those targets and the responsibilities of both the parties see point 8.

If one of both parties determine that the contract will not work and would like to end this contract, a termination of the contract is only possible by a written notice with a period of 1 month after announcement date.

2. Inter-Sprint Banden BV will pay a 2% HQ bonus to Fagdekk AS on all net sales to the members.

The bonus will be automatically calculated every quarter by Inter-Sprint Banden BV and paid the month following the quarter and will be communicated to you by email.
Fagdekk AS invoice this amount to Inter-Sprint Banden BV with 30 days net payment.

However only the paid invoices by the Fagdekk AS members will be taken into account in the monthly bonus calculation.

5. Pre-orders for summer - and winter tires are necessary for direct deliveries from China to the Fagdekk AS members, Inter-Sprint Banden BV will take in the:
 - Summer orders on October 15th the latest, delivery no later than 2nd week of April,
 - Winter orders at the latest on April 15th, delivery no later September 30th.
6. Summer pre-orders will be paid on May 31st, and winter pre-orders will be paid on November 30th. Replenishment orders will be paid on a 60 days net basis.

As all the sales of Inter Sprint Banden BV are covered by an insurance, the payment terms of 60 days are only possible if the Fagdekk AS member have a sufficient credit limit.


